Academy Cube e.V. is a non-profit education platform with a focus on digitization. Academy Cube is not pursuing any economic goals. The platform is run by an association that engages many individuals, academia, institutions, and businesses to develop and support digital careers.

Please read this Privacy Policy carefully before using this site.

Description of our services

Academy Cube helps talents to develop their digital career. The Academy Cube service is an online platform (www.academy-cube.com) that combines e-learnings with job profiles, jobs and blogs, with a dedicated focus on computer sciences, information technology, mathematics, natural sciences, and engineering.

Privacy and personal data

At Academy Cube we take your privacy very seriously. However, in order to provide access to our services we must collect and store some personal information about you.

In accordance with the EU General Data Protection Regulation we will collect as little information as possible and only data that is related to the purposes described in this Agreement (<https://www.eugdpr.org/>).

As far as possible, and as far as it is our responsibility, we implemented the EU data protection regulations on our Academy Cube platform. However, data protection & privacy concerns everyone. Therefore, please make sure to keep your browsers and operating systems (etc.) up to date.

What is collected?

Basic information is collected from you when you create your account including your full name, date of birth, country, and email address. This will enable you to access our learnings, job postings, and news blogs.

After signing up you may want to maintain your profile information, thus uploading your photo and adding your address, phone number, interests, educational background, work experience, and (language) skills. You may also want to upload your CV / resume and certificates (education, work, skills, etc.).

Maintaining your profile will enable you to be found by recruiters and / or apply to job postings. You can decide whether or not you want your profile to be seen by others by checking the “Visibility” checkbox.

Please be aware that as you use the Academy Cube site, information about the courses, jobs, activities and resources you interact with, will also be stored and linked to your profile information (tracking of type, duration and progress of curricula / courses consumed, of your log-in details to the training system and of your visits to individual job postings).

How is this information used?

The above-mentioned information is only used to provide you access to the online courses and job postings at www.academy-cube.com. Statistical information about usage of the site is also used to improve the site and services provided on the www.academy-cube.com website.

In case you check the “Visibility” checkbox, your profile information will be used by recruiters for job matching activities. We may use your personal data to conduct questionnaires and surveys about Academy Cube and its services. Your completion of any questionnaires is voluntary.

We may inform you to support recruiting inquiries and use the information you provided to communicate with you to manage the Academy Cube recruiting and hiring process. We may reply to your inquiries, to provide you with requested information and promotional material.

Automated decision-making or profiling

As a responsible company, we do not use automatic decision-making or profiling.

Who is my data shared with?

We collect your personal information to use, transfer, retain and share it internally, with other partners of Academy Cube e.V. and with third parties for the purpose of operating, promoting, and improving our services, as well as for recruiting processes.

Cookies in general

Cookies are small data files that are placed on your computer or mobile device when you visit a website. Cookies are widely used by online service providers in order to (for example) make their websites or services work, or to work more efficiently, as well as to provide reporting information.

Your Web browser may allow you to be notified when you are receiving a cookie, giving you the choice to accept it or not. By not accepting cookies, some pages may not fully function and you may not be able to access certain information on this site.

Some cookies are required for technical reasons in order for our Websites and Services to operate. Other cookies enable us to track and target the interests of visitors to our Websites.

We use cookies, for example, to tailor content and information that we may send or display to you and otherwise personalize your experience while interacting with our Websites and to otherwise improve the functionality of the Services we provide.

Session Cookie

The session cookie is used by Academy Cube to keep information about the current user session so that users do not need to repeatedly identify themselves. The cookie is deleted on logging out and after timeout (which is currently 3000 seconds of inactivity).

Google Analytics Cookie

This website uses Google Analytics, a web analytics service provided by Google, Inc. ("Google"), 1600 Amphitheatre Pkwy, Mountain View, CA 94043-1351, United States.

Google Analytics uses "cookies", which are text files placed on your computer, to help the website analyze how users use this site. The information generated by the cookie about your use of the website (including your IP address) will be transmitted to and stored by google on servers in the United States.

Within the framework of our network activities, we may process personal data like account names or email addresses in isolated cases. However, this will only happen sporadically.

Newsletters

In this section we would like to inform you about the content of our newsletter, the (un)subscription method, the sending of our newsletter, the statistical evaluation method, as well as your right of objection.

Newsletter Content

If you have subscribed to our newsletter, we may send you regular updates by e-mail on the latest Academy Cube announcements, or related events.

We may also contact you occasionally with tailored information about the Academy Cube offerings, e. g. curricula, courses, events, blog articles, or recommendations for specific job offerings, which we think will be of special interest to you.

Subscription to Newsletter via Double-Opt-In

The subscription to our newsletter is carried out via a so-called double-opt-in procedure. This means that, after registration, you will receive an email in which you will be asked to confirm your registration. This confirmation will prevent that users subscribe themselves with false email addresses.

According to legal requirements, registrations to our newsletter will be recorded for verification purposes. This recording includes information about the time and date of the registration / confirmation, as well as your IP address. To subscribe to our newsletter, it is sufficient to enter your email address, as well as your first and your last name.

Distribution of our Newsletter

We use the “MailChimp” service for the distribution of our newsletters. MailChimp is a newsletter distribution platform and belongs to the US service provider Rocket Science Group, LLC, 675 Ponce De Leon Ave NE #5000, Atlanta, GA 30308, USA.

MailChimp stores user data on servers located in the US. On behalf of us, your data is used by MailChimp for sending out our newsletter, as well as for analyzing purposes.

Moreover, MailChimp may use your data to optimize their services, e. g. to technically improve the distribution of newsletters, to optimize the visualization of newsletters, or for economic purposes to evaluate in which countries the addressees are located.

According to MailChimp, it will not pass on your data to third parties or use your data to contact you directly.

We have decided to use MailChimp for our newsletters due to the support they offer and because MailChimp offers excellent technical features and disposes of well-protected IT systems. MailChimp is EU-US privacy shield certified.

Statistical Analysis

Our newsletter contains so-called “web-beacons”, which are tiny pixel files that are recalled when a newsletter is opened on the MailChimp server. During these recalls technical information, information about your browser and your system, as well as your IP address are being collected.

This will enable us to see whether and when the newsletter has been opened and which links have been clicked. Technically, it would be possible to attach this data to a certain user. However, please rest assured that it is not our intention (nor the intention of MailChimp) to observe our users or to create profiles about them. On the contrary, our intention is to analyze general, anonymized reading behaviors to make our content more engaging and to improve its usefulness.

Learning Content

It may be that we link to certain courses on websites belonging to our content partners. Please be aware that in these cases you will have to register on the platforms of our content partners and adhere to their terms & conditions.

Assessments

Within the framework of our curricula, Academy Cube offers online courses that include individual assessments of a talent's work and, for talents who demonstrate their mastery of subjects, a certificate of achievement.

Profil and Job Seekers

For job applications which you, the job seeker, submit through Academy Cube (by clicking on the apply button) to an employer, (with related materials submitted), please note:

- 1) that your applications and materials may be controlled and downloaded by an employer,
- 2) we may direct you to that employer for personal data deletion requests, and
- 3) Academy Cube depends on the employer or the employer's agent to provide Academy Cube with the correct destination for all applications.

Academy Cube e.V. has no liability for such applications. If you do not wish to send your application materials in this manner, you should send them directly to the employer.

If you have chosen to make your profile public (incl. your CVs / resumes, certificates, etc.), you may get contacted with relation to your data.

Our partners are contractually required to treat your personal information in accordance with this Privacy Policy. Please also be aware that we may use third-party cloud service providers that provide hosting, data storage and other services pursuant to standard terms and conditions that may be nonnegotiable; these service providers have informed us or the general public that they apply security measures they consider adequate for the protection of information within their system, or they have a general reputation for applying such measures.
